NATIONAL POLICE WEEK - OFFICER SAFETY RESOURCES - 2024

In 2023, 378 law enforcement officers were shot in the line of duty, a 14% increase over 2022¹. As law enforcement agencies commemorate [National Police Week](#), May 11th – 16th, it is essential to honor the sacrifices of those who have served by striving to improve the safety and well-being of law enforcement personnel and their communities.

In addition to sponsoring community events, organizing and attending vigils to honor the fallen, and building key partners to help commemorate those who have been lost, we urge Chiefs of Police during National Police Week and throughout 2024 to focus on measures and actions to help keep officers safe.

- **Monday, Violent Person File: Critical to Officer Safety**

- **Wednesday, Seatbelts: Critical to Officer Safety**

- **Thursday, Ambush Attacks: Mitigation Considerations**
Ambushes have become a growing threat to law enforcement officers, and it's critical that agencies prepare their officers through effective training strategies and consider implementing an ambush threat mitigation plan. - **Friday, Officer Wellness: Critical to Performance and Officer Survival**
