### CATEGORY 2

Interstate but operating exclusively in transportation or operations excepted under 49 C.F.R. 390.3(f), 49 C.F.R. 391.2, or 49 C.F.R. 391.68 (**CDL Holder Self-Certification must be submitted to the NJMVC**).

Transportation performed by the federal government, a state, or any political subdivision of a state.

(Note: The NJMVC requires ALL passenger (P) endorsement holders, including government workers, to have a valid medical certificate on file with the National Registry in order to maintain the P endorsement on their CDL. N.J.A.C. 13:21-14.5(c) (6)

### CATEGORY 3

Intrastate and subject to state driver qualification requirements. (**Medical certificate must be on file with the National Registry and CDL Holder Self-Certification must be submitted to the NJMVC**.)

All Class A, B, and C drivers who do NOT fall under any of the other categories.

### CATEGORY 4

Intrastate, but operating exclusively in transportation or operations excepted from all or part of the state driver qualification requirements. (**CDL Holder Self-Certification must be submitted to the NJMVC**.)

Transportation performed by the federal government, a state, or any political subdivision of a state.
